

MAHONE BAY TOWN COUNCIL MEETING MINUTES – MAY 21, 1919

Meeting of the Town Council convened in Penney's Hall on above date.

Meeting called to order by Mayor Ernst at 8:10 o'clock p.m.

Present: Mayor and Councillors Begin, Cochrane, Smith, McLean, Fancy and Penney

Minutes of the last meeting were read and approved.
